Installation Instructions**



Thank you for making HOOKER HEADERS your choice in a high-performance exhaust system. Extensive dyno/track testing has enabled HOOKER to offer the most advanced design in exhaust systems. The installation, while not complex, will take a certain amount of time. However, the additional horsepower and improved performance will more than justify your efforts. Proper installation and maintenance will ensure long life and maximum performance from your HOOKER HEADER exhaust system.

**BEFORE STARTING:**

Your vehicle must be raised a minimum of 36 inches. A floor hoist is ideal. If no hoist is available, we strongly urge the use of axle stands as a safety measure. Please read these instructions in their entirety before attempting installation.

**CAUTION! WORK ONLY ON A LEVEL SURFACE. USE JACKS /JACKSTANDS OF SUFFICIENT CAPACITY TO LIFT AND SUPPORT YOUR VEHICLE. NEVER WORK UNDER A VEHICLE SUPPORTED BY A FLOOR OR BUMPER JACK.**

**INSTALLATION:**

1. Disconnect the negative cable from the vehicle battery.
2. Lift the vehicle and secure on jack stands.
3. From under the vehicle, refer to photo and locate this area of the OE mid pipe. This section of the OE mid pipe is near the rear differential.

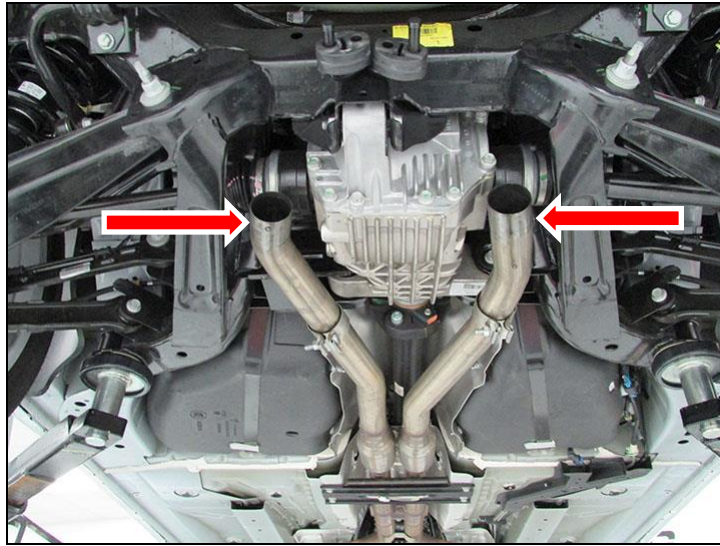

4. With a permanent marker, locate the tangent line (where the bend ends and the straight section of the pipe begins) of the left side OE mid pipe and mark a straight line. Now mark another straight line exactly 2.0" after your tangent mark (2.0" in the direction towards the rear of the vehicle). We suggest using masking tape to wrap around the OE mid pipe to ensure a straight cut. Draw arrows to ensure you cut at the correct side of the masking tape. **DOUBLE CHECK AND MEASURE TWICE BEFORE CUTTING.**

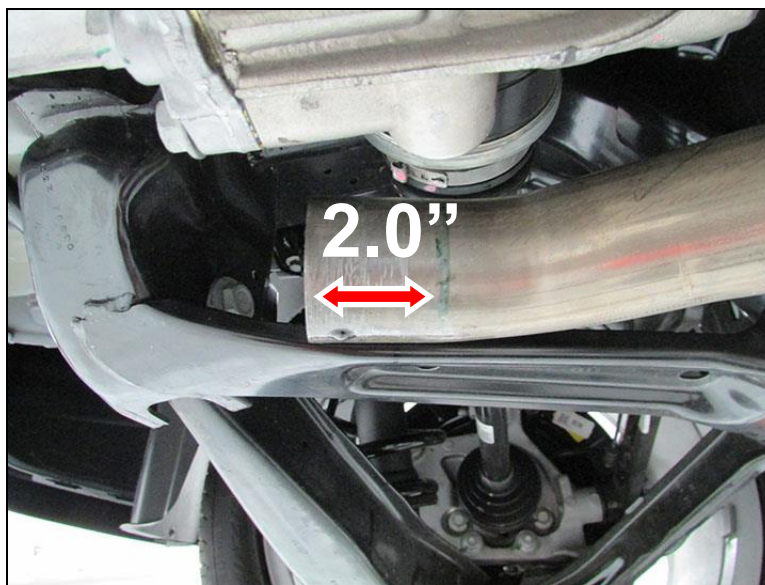
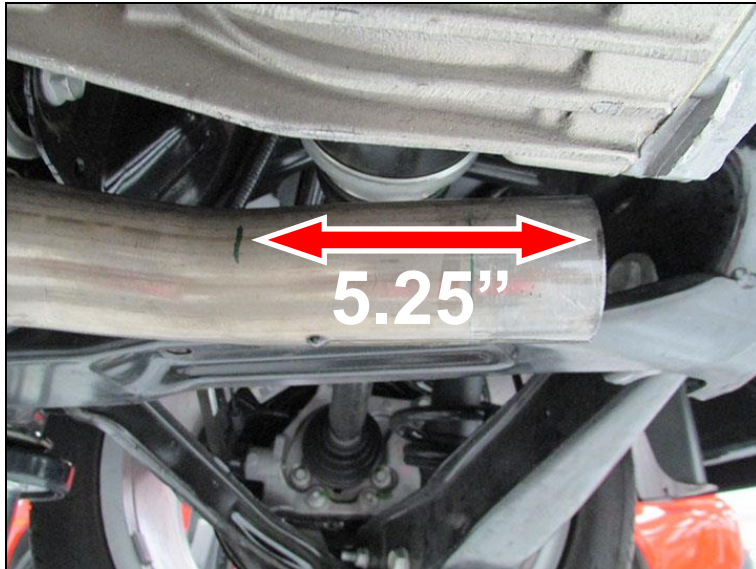

5. With a permanent marker, locate the tangent line (where the bend ends and the straight section of the pipe begins) of the right side OE mid pipe and mark a straight line. Now mark another straight line exactly 5.25" after your tangent mark (5.25" in the direction towards the rear of the vehicle). We suggest using masking tape to wrap around the OE mid pipe to ensure a straight cut. Draw arrows to ensure you cut at the correct side of the masking tape. **DOUBLE CHECK AND MEASURE TWICE BEFORE CUTTING.**

6. When complete, de-burr the inside and outside of the cut tube (**BE CAREFUL AS THE CUT ENDS WILL BE VERY SHARP**).
7. Remove the left and right side OE muffler sections by sliding the rubber isolation mounts off of the chassis.
8. On a workbench, remove the (x4) rubber isolation mounts off of the OE muffler sections and transfer onto the Blackheart Axle-Back Exhaust System.
9. Using (x1) 2.25" supplied band clamp, slide the left side Blackheart tail pipe section onto the OE mid pipe and secure the rubber isolation mounts back onto the chassis. Do not tighten the band clamp.
10. Using (x1) 2.25" supplied band clamp, slide the right side Blackheart tail pipe section onto the OE mid pipe and secure the rubber isolation mounts back onto the chassis. Do not tighten the band clamp.
11. Align the Blackheart Exhaust System including the left and right side tips to your desired position and tighten the (x2) band clamps from steps 9 and 10.
12. Connect the battery, start the engine, and check for leaks.
13. Re-check your work.
14. Remove the jack stands and lower the vehicle.
15. After 150 miles, re-check and tighten all bolts and clamps.

**NOTE: It is normal for the Blackheart Axle-Back Exhaust System to emit smoke for the first few minutes during break-in period.**
