

EXECUTIVE ORDER D-115-26

Relating to Exemptions Under Section 27156 of the California Vehicle Code

Holley Performance Products MSD 6EFI Universal EFI Ignition Part Number 6415

Pursuant to the authority vested in the California Air Resources Board by Section 27156 of the Vehicle Code; and

Pursuant to the authority vested in the undersigned by Section 39515 and Section 39516 of the Health and Safety Code and Executive Order G-19-095;

IT IS ORDERED AND RESOLVED: That installation of the MSD 6EFI Universal EFI Ignition, manufactured and marketed by Holley Performance Products, 1801 Russellville Road Bowling Green, Kentucky 42101, and its subsidiary MSD, has been found not to reduce the effectiveness of the applicable vehicle pollution control systems and, therefore, is exempt from the prohibitions of Section 27156 of the Vehicle Code for 1995 and older vehicles that do not have OBDII.

The MSD 6EFI Universal EFI Ignition is an external ignition conditioning module that connects to the ECU and ignition coils to improve spark performance. The device has an internal rev limiter and cylinder number selection that are adjustable through two rotary dials on one end of the device. Ignition timing is not adjustable through MSD 6EFI Universal EFI Ignition the by the end user.

This Executive Order is valid provided that the installation instructions for the MSD 6EFI Universal EFI Ignition will not recommend tuning the vehicle to specifications different from those of the vehicle manufacturer.

Changes made to the design or operating conditions of the MSD 6EFI Universal EFI Ignition, as exempt by the California Air Resources Board, which adversely affect the performance of the vehicle's pollution control system shall invalidate this Executive Order.

This Executive Order shall not apply to any MSD 6EFI Universal EFI Ignition advertised, offered for sale, sold with, or installed on a new motor vehicle prior to or concurrent with transfer to an ultimate purchaser.

Marketing of the MSD 6EFI Universal EFI Ignition using any identification other than those shown in this Executive Order or marketing of the MSD 6EFI Universal EFI Ignition for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from the California Air Resources Board.

This Executive Order does not constitute any opinion as to the effect the use of the MSD 6EFI Universal EFI Ignition may have on any warranty either expressed or implied by the vehicle manufacturer.

Exemption of the MSD 6EFI Universal EFI Ignition shall not be construed as an exemption to sell, offer for sale, or advertise any component of the assembly as individual devices.

This Executive Order is granted based on an evaluation of information supplied by Holley Performance Products and supporting data from prior Executive Orders.

The California Air Resources Board reserves the right in the future to review this Executive Order and the exemption provided herein to assure that the exempted add-on or modified part continues to meet the standards and procedures of Title 13, California Code of Regulations, Section 2222, et seq.

THIS EXECUTIVE ORDER DOES NOT CONSTITUTE A CERTIFICATION, ACCREDITATION, APPROVAL, OR ANY OTHER TYPE OF ENDORSEMENT BY THE CALIFORNIA AIR RESOURCES BOARD OF ANY CLAIMS OF THE APPLICANT CONCERNING ANTI-POLLUTION BENEFITS OR ANY ALLEGED BENEFITS OF THE MSD 6EFI UNIVERSAL EFI IGNITION BOX.

No claim of any kind, such as "Approved by the California Air Resources Board", may be made with respect to the action taken herein in any advertising or other oral or written communication.

Violation of any of the above conditions shall be grounds for revocation of this order. The order may be revoked only after a ten-day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request and the order may not be revoked until a determination is made after the hearing that grounds for revocation exist.
